What is OCS?

It is a voluntary program of the plastics industry designed to prevent pellets (*pellets or primary microplastics*) from going to the sea.

It is essential the commitment of everyone in companies, to avoid the loss of pellets.

Who is it for?

It applies to any company involved in the production, transport, storage and transformation of plastic raw materials, regardless of where the center(s) of activity is located.

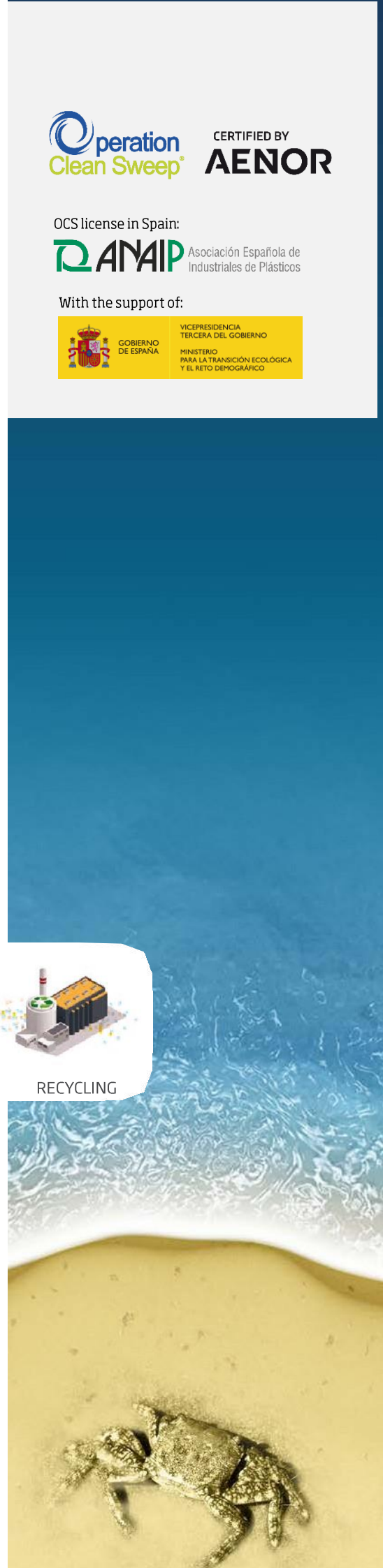

Wherein is?

Operation Clean Sweep® (OCS) consists of promoting the use of good cleaning and pellet control practices in all operations in which plastic pellets are handled, to minimize leaks to the environment.

Among these practices, AENOR certifies the degree of compliance with 5 main measures:

- 1 Make the "zero pellet loss" a priority.
- 2 Evaluate the situation and the needs of your company.
- 3 Make the necessary improvements in the facilities and equipment.
- 4 Sensitize employees and create a sense of responsibility.
- 5 Track and enforce procedures.

The guarantee of a committed global management

- Request detailed information on AENOR's certification process today.
- The application must be made by each production center where you want to apply for certification.
 - If you are certificate according to ISO 14001, the requirements of OCS herselfeasily integrate, on the basis of compliance with the volunteers agreements require.
 - If you are not certified according to ISO 14001, you can certify OCS.



AENOR certifies your commitment

Once adhered to the OCS, AENOR certifies the degree of implementation of the OCS scheme in your company on a regular basis, in accordance with the principles of impartiality and independence, as well as the requirements of the reference regulation, thus demonstrating compliance with the measures to which you have committed.

AENOR is the certification body in charge of the planning, realization and management of the certification process, from the receipt of the certification application

until the completion of the process, which includes the issuance of the final evaluation report and corresponding certificate, as well as the subsequent maintenance of the certification.
